Standards

The National Archives/TNA Standard for Record Repositories

ISAD(G) is the International Standard for Archive Description (General) and provides guidance for archival description and gives details and examples for the elements required to create a clear, concise, accurate and meaningful description of a collection

ISAAR is the International Standard Archival Authority Record for corporate bodies, persons and families and is produced by the International Council on Archives
